

LIMITED WARRANTY for the SeatRack Interior Cargo Rack Model SRA-01

FourLane, LLC ("FourLane") warrants to the original consumer purchaser of the SeatRack Product ("Product") that the Product shall be free of defects in workmanship and materials for one year from the date of original purchase. FourLane's obligation under this warranty shall be limited to repair or replacement during the warranty period. FourLane's liability shall not extend beyond repair or replacement, or the cost equivalent thereto. The warranty shall not be extended or renewed by the repair or replacement of the product. The warranty excludes normal wear and tear of the product and its parts and components, and damage arising from any of the following: use contrary to the Assembly, Installation and Use Instructions, negligent misuse of the product, and alteration of the product. If a customer believes that the Product is defective, the customer must return it to FourLane with proof of original purchase. FourLane may issue authorization for the return of the product. If an article is found to be defective upon inspection by FourLane, FourLane will repair or replace the defective article at its discretion without charge. The customer will pay freight to FourLane, and FourLane will pay any applicable return freight if the Product is found to be defective. Unauthorized returns will not be accepted. Normal wear and tear of the Product or damage resulting from misuse, accidents, or alterations are not covered by this Limited Warranty. The purchaser further acknowledges that FourLane has no control over the installation of the product and its use, or the attachment of items to the product. Accordingly, FourLane cannot assume responsibility for any bodily injury or death, or damage to property, vehicle and cargo arising from the installation or use of the product. This Limited Warranty applies only to SeatRack Products and not to other items used in conjunction with the Product. This Limited Warranty is in lieu of all other warranties, express or implied, and does not cover consequential damages of any kind that may arise from the use or misuse of all SeatRack products.

LIMITATION OF REMEDIES AND LIABILITY (READ CAREFULLY)

FourLane shall not be liable for any incidental or consequential damages for breach of any express or implied warranty for this product. Neither FourLane or any person involved in the creation, production, sale, or delivery of the product shall be liable for any bodily injury or death or damages of any type, including but not limited to lost property, profits, savings, or other incidental or consequential damages which may arise out of the purchase, use, or inability to use the product, whether arising out of contract, negligence, strict tort, or under any warranty, or otherwise, even if you have been advised of the possibility of such damage or any other claim by any other party.
